PROFESSIONAL SERVICES

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF

\$1,895

Our charge for basic services includes, but is not limited to, the services of our Funeral Directors and Staff to respond to initial requests for service; arrangement conference with the family or responsible party; arrangement of the funeral preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during and following the funeral, including coordinating service plans with cemetery, crematory and any other parties involved, receiving and arranging flowers and customary sheltering of the deceased. Included in this charge are our overhead expenses for operating this funeral service provider, such as responding 24 hours a day to calls, accounting and billing, secretarial and administrative costs, maintenance and utility expenses, equipment and inventory expenses, insurance expenses and similar overhead expenses. **This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you selected. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)**

EMBALMING

\$995

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

OUTER BURIAL CONTAINERS

Our outer burial container prices range from \$750 to \$2,750

In most areas of the country, state or local law does not require you buy a container to surround the casket in the grave.

However, many cemeteries require that you have such a container so that the grave will not sink in. Either a grave liner or a burial vault will satisfy these requirements.

FORWARDING REMAINS TO ANOTHER FUNERAL HOME \$2,595

This charge includes: basic services of Funeral Director and Staff, transfer of the remains to funeral home; embalming or other preparation of the deceased, arranging for and obtaining all necessary documents and permits, and local transportation to common carrier, but not shipping charges. This charge does not include visitation or ceremonies; merchandise; cash advances; taxes or any additional charges.

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME \$2,595

This charge includes: basic services of Funeral Director and Staff, transfer of the deceased from the local common carrier to the funeral home, temporary shelter and care of remains and transportation of the deceased to the cemetery. This charge does not include visitation or ceremonies. (Applicable only when remains are encased in a casket purchased out of town).

BASIC COORDINATION OF BURIAL OR ENTOMBMENT OF CREMATED REMAINS \$450

Applicable when a cremation is performed by another cremation agency or funeral home.
Scheduled ceremony and cemetery/mausoleum fees additional.

DIRECT CREMATION \$2,645

This charge includes: basic services of the Funeral Director and Staff, transfer of the remains to funeral home; shelter of remains, arranging for and obtaining all necessary documents and permits. This charge does not include visitation or ceremonies prior to cremation of the body, county permit fees, crematory fee, and sales tax.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.

IMMEDIATE BURIAL OR ENTOMBMENT \$2,995

This charge includes: basic services of the Funeral Director and Staff, transfer of the remains to funeral home; placement of unprepared remains into casket selected, arranging for and obtaining all necessary documents and permits, and local transportation to the cemetery. This charge does not include visitation, or ceremonies prior to interment or entombment of the body, sales tax and cemetery.

ANATOMICAL DONATION \$2,395

This charge includes: basic services of the Funeral Director and Staff, transfer of the remains to funeral home; shelter of deceased, delivery of deceased for scientific study, and arranging for and obtaining all necessary documents and permits. This charge does not include visitation or ceremonies prior to interment of the body.

DISINTERMENT

This charge includes coordinating and supervising disinterment and re-interment of an intact burial container or vault, including arranging for and obtaining all necessary permits and authorizations \$2,695

This charge includes the above professional services and when circumstances require us to physically transfer the remains from the casket or outer burial container (does not include the cost of new casket, outer burial container or any disposal charges) \$3,695
